## Overview

Leslie M. Altman advises and represents public and private sector employers in a broad range of employment law matters, with particular expertise in the area of workers' compensation. She is the former co-chair of Littler Mendelson's Workers' Compensation Practice Group and is well-versed in the laws and acts specific to workers' compensation in Minnesota and Wisconsin. She also often speaks at continuing legal education seminars on workers' compensation issues.

From 1983 until 1985, Leslie served as a special assistant attorney general at the Minnesota Attorney General's office, assigned to the Minnesota Department of Labor and Industry. In this capacity, she represented the commissioner in litigation challenging the 1983 reforms to the Workers' Compensation Act. In 1985, Governor Rudy Perpich appointed Leslie as the first woman judge on the Minnesota Workers' Compensation Court of Appeals, a position she left in 1988 to enter private practice.
